Covering an area of more than 500 acres, the estate provides a range of business space from a single office within the East Malling Business Centre, through to an entire self-contained office building located within the parkland setting surrounding Bradbourne House.



East Malling Business Centre

The Business Centre offers flexible, serviced office accommodation for small to medium sized businesses within two former research buildings – The Manwaring Building and The Oast.

Suites start from 100 sq.ft and are available on internal repairing terms and benefit from on-site services including:

Bradbourne House and Bradbourne Stables

Built in the early 1700s, Bradbourne House and the adjoining Bradbourne Stables, were home to the Twisden family for over 400 years. Purchased by The East Malling Trust in 1938 both the House and Stables now provide a mix of self-contained offices with historic character, ranging from 150 sq.ft to 2,750 sq.ft, together with meeting and conference rooms.



Park Farm

Park Farm comprises a range of former farm buildings which have been converted and refurbished to provide a range of self-contained offices from 750 sq.ft to 3,035 sq.ft.







East Malling Research traces its roots back to March 1913 when 22 acres of land at East Malling were purchased by a group of local farmers to establish an experimental research station for fruit-related sciences.

Through its subsequent success in the fruit industry, East Malling Research became the established name and the leading provider of horticultural research.

100 years on and research remains at the heart of the Estate as a centre of scientific excellence with laboratories, environmentally controlled polytunnels, greenhouses and concept orchards.
